Influenza and COVID 19 Vaccination

Influenza vaccination season is approaching. Attached is the current Vaccine Information Sheet, also known as VIS, for the seasonal influenza vaccination. Annual Influenza doses will be administered early to mid-October as per usual routine to those residents that historically get their annual influenza vaccination. CMS requires that the annual influenza be offered to those that have previously refused giving everyone equal opportunity, for those residents that again refuse an updated refusal will need to be signed. Also, as you may have heard in the news, "new booster" doses of Covid 19 vaccine have been approved by FDA and CDC. Eligibility for Moderna is 18 years old or older and Pfizer is 12 years old or older if it's been two months since primary series or since last booster. The new Bivalent Covid 19 Booster replaces previous booster recommendations. As supply arrives, doses will be administered, early September. Reminder that NDHC has previously obtained authorization for the Covid 19 Vaccinations including any additional dose recommendations to keep our residents up to date and safe. I am cautiously optimistic that covid boosters maybe a yearly booster much like influenza, but those future recommendations are yet to be determined.

COVID Regulatory Relief

In late September, the CDC has issued some revised guidance on COVID guidelines. In review, it looks like most of the relief is in one area, the testing of people without symptoms. We are pleased to see some movement. We are still hoping for more relief on mask wearing for fully vaccinated staff and data reporting. The data reporting requirements are still as stringent as early in the pandemic. The data set is not nearly as dynamic. It is in fact quite static from week to week. We believe that quarterly reporting would be more than sufficient.

The letter campaign continues with now over 1,000 sent from North Dakota and close to 2,000 nationwide. Letter campaigns in other states were later than North Dakota so we are hoping to see this number grow considerably.

Building Plan Update

- The Bank of North Dakota has approved
 6 million in loans at 1% interest.
- The USDA is financing the largest share of the project and gave us approval in September. ds.
- 3. Pricing for the project is being refined to current market conditions.
- 4. A bank has been chosen to provide financing during the construction period. Once the construction is complete, the USDA and Bank of North Dakota funding will replace the construction funding.

Renderings of the project are now made and will begin to be shared publicly.
